

ORDINANCE TO AUTHORIZE THE MAYOR TO PURCHASE TWO INTERNATIONAL TRUCKS AND RELATED EQUIPMENT FOR THE STREET DEPARTMENT AND REMOVE TWO (2) TRUCKS AND RELATED EQUIPMENT FROM THE ASSET LIST; AND DECLARING AN EMERGENCY.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF REYNOLDSBURG, OHIO:

SECTION 1. That the Mayor be and is hereby authorized and directed to purchase from Rush Truck Center, 11775 Highway Dr. Cincinnati Ohio 45241, two (2) truck chassis for a cost not to exceed one hundred forty seven thousand eight hundred ninety six dollars (\$147,896.00).

SECTION 2. The purchase shall be made through the Ohio State Contract bid list Number OH #023-18

SECTION 3. That the Mayor be and is hereby authorized and directed to purchase from Ace Truck and Body, 1600 Thrailkill Rd. P.O. box 459 Grove City Ohio 43123 two (2) Flink snow plows for a cost not to exceed twenty eight thousand eight hundred fifty eight dollars (\$28,858).

SECTION 4. That pursuant to Reynoldsburg City Code Section 175, competitive bidding is hereby suspended.

SECTION 5. That the Mayor be and is hereby authorized and directed to purchase and have installed (2) hydraulic systems, beds, spreaders, and lights from Pengwyn, 2550 West Fifth Ave. Columbus Ohio 43204 at a cost not to exceed fifty two thousand, three hundred sixty three dollars (\$52,363).

SECTION 6. The purchase shall be made through ODOT contract #835-17.

SECTION 7. That the City Auditor remove two (2) trucks and related equipment from the asset list to be traded into Rush Truck Center, 11775 Highway Dr. Cincinnati, Ohio, 45241 for a trade in value of eleven thousand dollars (\$11,000) and are described as follows:

SECTION 8. That this ordinance is deemed to be an emergency measure necessary for the financial needs of the City's government, and further to allow the purchase in a timely manner and to place the equipment into operation as soon as possible; wherefore upon adoption by Council this ordinance shall be in effect immediately upon signature by the Mayor.
